

### REQUEST FOR EXTENSION

I'm writing to request an extension for my 2019 short film Grant Project My Grandma the Sun. The funds to move this project past beginning stages came in very late. I was not in the position to self-fund prior to receiving the funds. When the funds were finally received,

- I was in the middle of several of my most intense work projects and I could not fully step away to devote all of my time to the film.
- Additionally, Katie Mafnas was in the process of moving off island. She was a key part of the project as Director of Art Department which involves finding and ordering, borrowing, renting all of the set pieces as well as the wardrobe. She was also the contact person for the at-risk youth.
- Finally, the location that we'd arranged to use was no longer available to us since it was much later than what we'd arranged for.

While I have worked through each of these challenges, and we are in the process of preparing for film day (rehearsals scheduled and final set pieces arriving in the mail), I don't want to rush through the filming, edit or audio design to meet the deadline. I'd also like to give some time to promote the screening date.
