GUAM COUNCIL ON THE ARTS AND HUMANITIES AGENCY Regular Board Meeting Minutes March 12, 2024

The Guam Council on the Arts and Humanities Agency's regular board meeting was called to order at 3:00 pm by Chairwoman of the Board, Monica Guzman.

Chairwoman Monica Guzman asks guest to sign in and hold all comments and questions until the end of the meeting.

III. REVIEW AND APPROVAL OF MINUTES

Donna Kloppenburg makes a motion to approve the February minutes. Simone Bollinger seconds the motion to approve the minutes based on corrections. Motion Carries

Revolving Fund Report / Audit

Acting Director Angie Taitague requests to table the financial report. Donna Kloppenburg motions to table the financial report, Mayor Jessy Gogue seconds. Motion Carries.

Chairwoman Monica Guzman states two options and present to the board

Acting Director Angle Taitague adds that she would like the applications physically dropped to the CAHA office. Discussion on process of submitting applications.

Chairwoman Monica Guzman asks if there is a motion on the floor to accept one of the options presented by the Acting Director. Vice Chair Max Ronquillo motions to elect option two and open a new call out for the 13th FESTPAC Delegation to represent Guam in HI. Mayor Jessy Gogue seconds. Chairwoman asks if there is any more discussion before the vote.

Vice Chair Max Ronquillo verifies electronic applications will be accepted to the email festpacquam@caha.guam.gov

Chairwoman states CAHA is the mandated by law to be the lead agency in FESTPAC and is responsible to send a delegation that best represents Guam. With the process in place they can be documented and properly vetted.

Simone Bollinger Piggy backs off of the Chairwoman's statement and addresses the elephant in the room that ALL delegates must be in good standing and have the respect of their community.

Continued discussion on electronic applications.

Chairwoman Monica Guzman reiterates there is a motion on the floor by Max and second by the Mayor to elect option two and conduct a new call out. Vote was cast and Motion Carries.

Vice Chair max Ronquillo motions to expend from the revolving account, funds to expedite ads in the newspaper not to exceed 2 half page ads. Donna Kloppenburg seconds. Motion Carries.

Mayor Jessy Gogue acknowledges visiting public trying to ask questions and reminds them public discussion is not usually granted during Board of Directors Meetings.

Chairwoman Monica Guzman refers back to agenda Item 6

IX. ANNOUNCEMENTS

 Chairwoman Monica Guzman states as discussed; the board will acknowledge the public one by one in order of the sign in sheet.

Andrew Gumataotao- States he is part of a study group of music and dance in Oceania, and would like contact information on how he can help disseminate information to his study group and future delegates. Andrew asks how the selection process goes for FESTPAC Delegates. Chairwoman Monica Guzman explains the process.

Siobahn Mcmanus-Siobahn thanks Simone Bollinger for her comments and appreciates that someone on the CAHA board cares about the community standing part of the selection process. Siobahn speaks about how the cultural arts community does not feel safe and feels better that there is a "strong" showing to revisit the selection process.

Chairwoman Monica Guzman asks the public to keep the comment of a minute so we can get through the long list.

Frank "Ko" SanNicolas- Mentions he does not appreciate the smirks coming from an individual from the public, then states he has nothing further to say.

Shannon Mcmanus- "Echoed" what her sister Siobahn said.

Tori Manely- States that she would like to sever the norm of sexual predators in our culture and that they be held accountable for their actions, whatever the evidence may be.



Star Dressler- States that she would like to "Call out" the person who responded to her emails, Vice Chair Max Ronquillo, because they "felt" disrespectful and off putting. Collette Palomo- States the questions, why are you choosing to prolong taking "Ko" off of the delegate list? How many more women do you need to come forward and ask you to take him off?

Vice Chair Max Ronquillo responds that everyone has been taken off the list. Mayor Jessy Gogue chimes in and states, we have agreed to do a new callout. He explains that the legal recommendation was to their role as the CAHA Board of Directors and explains the new list will give everyone an opportunity to apply and adhere to the same procedures and guidelines. Regardless of who applies, everyone will be vetted the same way. Mayor then makes it clear that the list is chosen by the Festpac committee chairs. The board takes the list from the chairs and determines whether or not that is an appropriate list to properly represent Guam in the 13th Festpac in Hawaii.

Simone Bollinger explains that the chairs are responsible for their selections and the chairs have chosen to move forward in this manner. Simone states as a board member she supports the chairs. If she feels the list does not best represent Guam in the best way, she feels everyone will be "Right back here"

Argumentative dialogue

Moneka Flores- we are here to make sure our community is heard. Please keep ALL this in mind when making your new selections.

"A" Stephens-Appreciates the decision to select new delegates and asks the board if they had Mothers, Daughters or women in their lives. Then asks what would you do if they were sexually assaulted by someone and that person was set free by the court of law. She then states, you would do whatever it takes to get justice.

Argumentative dialogue

Chairwoman Monica Guzman goes back to the agenda, Item 10 Adjournment. Donna Kloppenburg moves to adjourn, Mayor Jessy Gogue seconds.

Public guest speaks out and asks if max was going to say anything

Vice Chair Max Ronquillo begins to read his statement

Argumentative dialogue

Mayor Jessy Gogue chimes in to state that there is dialogue going back and forth that is not on the agenda and the official Board of Directors meeting should be adjourned.

Vice Chair Max Ronguillo asks if he could please finish his statement.



Public aggressive arguments break out. Public guest makes it known that she is not part of this meeting and is not as respectful as the others.

Chairwoman Monica Guzman calls for the motion on the table to adjourn!

I. OVERVIEW & STATEMENT OF PURPOSE –

- 1. The execution of Guam' presentation at the 13th Festival of Pacific Arts and Culture a.k.a. Festpac to be held in Hawaii from June 6-16, 2024; and
- 2. Showcasing the best representation of Guam's dynamic traditional and contemporary art forms of the highest caliber reflective of Guam's Culture, Heritage and CHamoru Values; and
- 3. Ensuring that Guam's distinct voice is heard among the people of the Pacific Region and to bring a greater awareness of the cultural richness of Guam to the world; and
- 4. Creating awareness, appreciation, pride and expression of the unique CHamoru heritage, language and history; and
- 5. Sharing their artistry and cultural traditions with other delegates and visitors to the festival in the spirit of Inafa'Måolek, Gofli'e, yan Geftao.

II. DELEGATE SELECTION CRITERIA

- A. Must be accomplished, skilled, well-versed and actively engaged practitioner in the genre or discipline that they wish to serve.
- B. Must show evidence of skill and work in their respective genre that have audience appeal, educational value and of the high-quality workmanship and craft that is suitable to represent the best of our CHamoru people.
- C. Must submit samples of work, and supporting materials such as photographs and articles, awards, and testimonials.
- D. Must be 18 years and older.
- E. Must be of good moral standing, known to practice CHamoru values of Respetu, Inafa'maolek, Gofli'e, yan Geftao; and not have any outstanding or previous felony charges or a registered sex offender.
- F. Must not be a drug or alcohol user or abuser.
- G. Must be a resident of Guam for one entire year prior to official callout.
- H. Must be able to participate in all FestPac related activities and events leading up to the 13th FestPac.

I. Delegates will be chosen based on a combination of artwork portfolio, professional/volunteer experience, and cultural relevance in medium, methods, and content of works; recognized by peers and community to practice CHamoru values.

III. GENRES

1. Demonstrations/ Exhibitions include:

- a) Visual Arts: Traditional and contemporary expressions of culture, including drawing, painting, printmaking, illustrations, graphics, sculpture/ 3D work, multimedia installations and pottery.
- b) Floral Arts: Plants and flowers are woven into our cultures, expressing the values, traditions and contemporary ideas that shape who we are; demonstrations, exhibits, interactive lessons, and discussions.
- c) Culinary Arts: Demonstrations and workshops on CHamoru cuisine, offering an exquisite taste of traditional and contemporary flavors, including traditional Hotno (brick/stone oven baking), keleguen, lechen niyok and tunu methods, concepts of Agun and To'tsi, with demonstrations, lessons, and tasting.
- d) Canoe Voyaging: Seafaring activities, demonstrations, discussions, workshops and displays.
- e) Photography: Workshops, exhibits, discussion, interactive lessons in particular techniques.
- f) Healing Arts: Healing practices that apply traditional wisdom to modern-day life, including massage, birthing methods, and use of medicinal plants in displays, discussions and sharing knowledge.
- g) Body Ornamentation: Featuring traditional, hand-crafted adornments along with contemporary jewelry.
- h) Carving: Demonstrations of the robust carving traditions of CHamoru people in wood, stone, bone, coconut artistry.
- i) Heritage arts: Past and contemporary cultural and scenic images using artfully crafted materials as listed in separate genres. These are often associated with the public marketplace.
- Storytelling traditionally and through new mediums.
- k) Film: New Media and Digital Storytelling, short films, documentaries and feature-length works by Guam filmmakers, held in conjunction with workshops and forums.
- 1) Traditional Games, specifically creating awareness of ancient skills and practices, i.e. slinging.
- m) Weaving: Demonstrations of weaving traditions of the CHamoru people, along with hands-on workshops, weaving displays and discussions.
- n). Tattooing: Demonstrations of tattoo, illustrating the cultural and genealogical roots of this striking Oceanic tradition.
- o). Blacksmithing of traditional CHamoru tools, including demonstrations of their use.

IV. OVERVIEW & STATEMENT OF PURPOSE - Literary Arts

A. The Literary Arts Delegation is responsible for:

- 1. Bringing an appreciation, pride, and expression of the unique CHamoru heritage, language and history through Publications and Indigenous Languages; and
- 2. Showcasing the literary work of CHamoru authors who have written in the CHamoru language, English, or bilingually and could either be published or unpublished; and
- 3. Establishing a daily translation of CHamoru words, phrases, and sentences; and

- 4. Exhibiting the CHamoru language use with graphics, photography, posters, and/or maps in exhibits or booths: and
- 5. Presentations that bring focus to the importance of maintaining indigenous languages as a core cultural value.

B. Genres

- 1. Publications includes contemporary, indigenous, graphics, anthologies, academic; Guam Pacific island stories and novels; biographies and journals; and novelists, writers, poets, and seminars.
- 2. Indigenous Languages includes written, oral, read; translations, orthographies, lexicography, documents and media usage of language, workshops and seminars and on-the-spot translations.

C. DELEGATE SELECTION CRITERIA

- 1. Publications
- a) Must have an interest in presenting stories that highlight the experience of the indigenous CHamoru people of Guam.
- b) Must produce/present work that relates to Guam and connects with the 13th Festival of Pacific Arts theme.
- 2. Indigenous Languages
- a) Must be a traditional, native speaker and/or an SLA (Second Language Acquisition) of CHamoru language.
- b) Must have the ability to communicate in the CHamoru language at the basic level.
- c) Must have basic knowledge of historical contexts of the loss of the CHamoru language.
- d) May be a publisher of native language books for language materials exhibits to be used at the festival.

V. OVERVIEW & STATEMENT OF PURPOSE – Performing Arts

A. The Performing Arts Delegation is responsible for:

- 1. Showcasing the best representation of Guam's dynamic performance art forms of the highest caliber reflective of Guam's Culture and Heritage; and
- 2. Ensuring that Guam's distinct voice is heard among the people of the Pacific Region and to bring a greater awareness of the cultural richness of Guam to the world; and
- 3. The promotion of CHamoru the indigenous language of the people of Guam; and
- 4. Creating an awareness and pride in CHamoru heritage though performance arts; and
- 5. Sharing their artistry and cultural traditions with other delegates and visitors to the festival.

B. GENRES

- 1. Cultural heritage dance: contemporary and traditional dances, songs and chants of the indigenous people of Guam.
- 2. Theatre, dance, performance work for staging within a theater context: theatrical performances that give voice to the diversity of issues confronting Guam and the Pacific Islanders in the modern world, as well as, our island's rich cultural heritage.
- 3. Music, live cultural music, bands, acoustic music, chants, traditional instruments
- 4. Storytelling and oral traditions: live performances featuring Guam's oral traditions and storytelling.
- 5. Wearable art, adornment, and textiles: fashion, textiles focused on cultural practices and engaging in Guam's designs, patterns, and symbology.

C. DELEGATE SELECTION CRITERIA

- 1. Must be available and committed to schedule practices to learn the performance presentation that encompasses the (opening and closing ceremony of the festival, and the daily two-week schedule performance presentation).
- Speaking/usage of the CHamoru language a plus, but not a mandatory requirement.
- 3. Must be able to work well with others especially large numbers in order to present unified performing arts delegation.

I. OVERVIEW & STATEMENT OF PURPOSE –

- 1. The execution of Guam' presentation at the 13th Festival of Pacific Arts and Culture a.k.a. Festpac to be held in Hawaii from June 6-16, 2024; and
- 2. Showcasing the best representation of Guam's dynamic traditional and contemporary art forms of the highest caliber reflective of Guam's Culture, Heritage and CHamoru Values; and
- 3. Ensuring that Guam's distinct voice is heard among the people of the Pacific Region and to bring a greater awareness of the cultural richness of Guam to the world; and
- 4. Creating awareness, appreciation, pride and expression of the unique CHamoru heritage, language and history; and

II. DELEGATE SELECTION CRITERIA

- A. Must be accomplished, skilled, well-versed and actively engaged practitioner in the genre or discipline that they wish to serve.
- B. Must show evidence of skill and work in their respective genre that have audience appeal, educational value and of the high-quality workmanship and craft that is suitable to represent the best of our CHamoru people.
- C. Must submit samples of work, and supporting materials such as photographs and articles, awards, and testimonials.
- D. Must be 18 years and older.
- E. Must be of good moral standing, known to practice CHamoru values of Respetu, Inafa'maolek, Gofli'e, yan Geftao; and not have any outstanding or previous felony charges or a registered sex offender.
- F. Must not be a drug or alcohol user or abuser.
- G. Must be a resident of Guam for one entire year prior to official callout.
- H. Must be able to participate in all FestPac related activities and events leading up to the 13th FestPac.

I. Delegates will be chosen based on a combination of artwork portfolio, professional/volunteer experience, and cultural relevance in medium, methods, and content of works; recognized by peers and community to practice CHamoru values.

III. GENRES

1. Demonstrations/ Exhibitions include:

- a) Visual Arts: Traditional and contemporary expressions of culture, including drawing, painting, printmaking, illustrations, graphics, sculpture/3D work, multimedia installations and pottery.
- b) Floral Arts: Plants and flowers are woven into our cultures, expressing the values, traditions and contemporary ideas that shape who we are; demonstrations, exhibits, interactive lessons, and discussions.
- c) Culinary Arts: Demonstrations and workshops on CHamoru cuisine, offering an exquisite taste of traditional and contemporary flavors, including traditional Hotno (brick/stone oven baking), keleguen, lechen nivok and tunu methods, concepts of Agun and To'tsi, with demonstrations, lessons, and tasting.
- d) Canoe Voyaging: Seafaring activities, demonstrations, discussions, workshops and displays.
- e) Photography: Workshops, exhibits, discussion, interactive lessons in particular techniques.
- f) Healing Arts: Healing practices that apply traditional wisdom to modern-day life, including massage, birthing methods, and use of medicinal plants in displays, discussions and sharing knowledge.
- g) Body Ornamentation: Featuring traditional, hand-crafted adornments along with contemporary jewelry.
- h) Carving: Demonstrations of the robust carving traditions of CHamoru people in wood, stone, bone, coconut artistry.
- i) Heritage arts: Past and contemporary cultural and scenic images using artfully crafted materials as listed in separate genres. These are often associated with the public marketplace.
- j) Storytelling traditionally and through new mediums.
- k) Film: New Media and Digital Storytelling, short films, documentaries and feature-length works by Guam filmmakers, held in conjunction with workshops and forums.
- 1) Traditional Games, specifically creating awareness of ancient skills and practices, i.e. slinging.
- m) Weaving: Demonstrations of weaving traditions of the CHamoru people, along with hands-on workshops, weaving displays and discussions.
- n). Tattooing: Demonstrations of tattoo, illustrating the cultural and genealogical roots of this striking Oceanic tradition
- o). Blacksmithing of traditional CHamoru tools, including demonstrations of their use.

IV. OVERVIEW & STATEMENT OF PURPOSE – Literary Arts

A. The Literary Arts Delegation is responsible for:

- 1. Bringing an appreciation, pride, and expression of the unique CHamoru heritage, language and history through Publications and Indigenous Languages; and

- 5. Presentations that bring focus to the importance of maintaining indigenous languages as a core cultural value.

B. Genres

- 1. Publications includes contemporary, indigenous, graphics, anthologies, academic; Guam Pacific island stories and novels; biographies and journals; and novelists, writers, poets, and seminars.
- 2. Indigenous Languages includes written, oral, read; translations, orthographies, lexicography, documents and media usage of language, workshops and seminars and on-the-spot translations.

C. DELEGATE SELECTION CRITERIA

1. Publications

- a) Must have an interest in presenting stories that highlight the experience of the indigenous CHamoru people of Guam.
- b) Must produce/present work that relates to Guam and connects with the 13th Festival of Pacific Arts theme.
- 2. Indigenous Languages
- a) Must be a traditional, native speaker and/or an SLA (Second Language Acquisition) of CHamoru language.
- Must have the ability to communicate in the CHamoru language at the basic level.
- c) Must have basic knowledge of historical contexts of the loss of the CHamoru language.
- d) May be a publisher of native language books for language materials exhibits to be used at the festival.

A. The Performing Arts Delegation is responsible for:

- 1. Showcasing the best representation of Guam's dynamic performance art forms of the highest caliber reflective of Guam's Culture and Heritage; and
- 2. Ensuring that Guam's distinct voice is heard among the people of the Pacific Region and to bring a greater awareness of the cultural richness of Guam to the world; and
- 3. The promotion of CHamoru the indigenous language of the people of Guam; and
- 4. Creating an awareness and pride in CHamoru heritage though performance arts; and
- 5. Sharing their artistry and cultural traditions with other delegates and visitors to the festival.

B. GENRES
