# IV. EXECUTIVE DIRECTOR REPORT:

- Revolving Fund Report / Audit
  - a. Guam Revolving Checking Account Balance as of January 22, 2023, is fifty-three thousand eight hundred and sixty dollars and thirty-five cents. \$53,860.35
  - b. FESTPAC Checking Account Balance as of January 22, 2023, is three hundred thirty-two thousand four hundred and eighteen dollars and forty-five cents. \$332,418.45.
    - c. Percent for the Arts Checking Account Balance as of January 22, 2023, is four hundred thirty thousand four hundred fifty-six dollars and seventy-five cents. \$430,456.75.

- Traditional Master's Program: Chairwoman Monica Guzman states, on your question Angie with the Traditional Masters Program, I would like board recommendation. Max mentioned we are in an off year, but I do not want to wait until 2026. It has been 9 years, and we need to move forward. Vice Chair Max Ronquillo agrees we should move forward however the law is clear and suggests we ask Peaker and Senator Barnett what their feelings are as it should be as easy as adding in a writer to their next legislative session. Donna Kloppenburg also agrees we need to move forward. Frank Rabon expresses his concerns about aging eligible artists who would become masters and suggests Guam CAHA internally awards them as Masters before its too late. Open discussion on the regs of the program. Frank mentions he wants to protect the integrity of the program and not let just any Tom, dick and Harry receive the award and that the 2 individuals he mentioned fall in line and meet the criteria of the regs and the amended law and we should award them. Chair Monica Guzman agrees they should be recognized for their service, but what manner or title will we give them. Chair then asks can we recognize Masters without going through the process. Frank



responds, No. Open discussion on the rules and regs. Chair Monica Guzman tables discussion until Vice Chair Max Ronquillo gets to the meeting in person to read the law.

#### V. FESTPAC

Chair Monica Guzman states report was given to the board and the only addition to the report is. Madam Chair has confirmed with GVB that in addition to the anticipated RFQs for hut design, uniforms, fabric design and delegation gifts, there may be additional RFQs submitted from the different genres for costume and equipment needs.

More discussion on past topics of the Master's program. Chair Monica Guzman states we are all on the same page and would like a resolution created to put on the agenda for Feb BOD meeting.

Acting Executive Director Angie Taitague sent out proposed Interest rates for TCD account to the board. Recommendations to come when Mayor Jessy Gogue can sit down with the staff and go over accounts and options.

#### 2. Executive Director Nomination: Angle Taitague

Chairwoman Monica Guzman reads the letter from Governor Lou Leon Guerrero nominating Angie Taitague as the Executive Director of Guam CAHA. The chair also states that according to the Guam Code Annotated (GCA) All we need to do is give motion, accept nomination, vote, and send a letter from the board to the Governor on the appointment. Is there a motion on the floor to accept the nomination from the Governor? Donna Kloppenburg makes the motion. Mayor Jessy Gogue seconds.

Mayor Gogue discusses that the board is supporting the nomination from the Governor, but the decision still must go to a confirmation hearing with the legislature. Acting Director Angie Taitague states that according to protocol the board must write a resolution accepting the nomination, then sent to protocol and then protocol will send the resolution to the legislature. Chairwoman Monica Guzman states that she spoke with the Governor's legal team and was instructed to proceed via letter back to the Governor. She then reads the GCA law. Vice Chair Max Ronquillo would like to provide some scrutiny making sure that Acting Director Angie Taitague understands she will be transitioning to a non-classified position and understands the risk that comes with that.



Motion Carries to accept the Governors nomination of Angie Taitague as the Executive Director of Guam CAHA.

Chair Monica Guzman gives her guidance about solidifying SOPs for the agency. Vice chair Max Ronquillo suggests creating a stronger relationship with the Guam Museum.

RESOLUTION NO: 2024-001

RELATIVE TO THE GUAM COUNCIL ON THE ARTS AND HUMANITIES AGENCY (CAHA) NOMINATION PROCESS FOR THE GUAM MASTERS AWARD IN ACCORDANCE WITH TITLE 5 – GOVERNMENT OPERATIONS, DIVISION 8 – CULTURAL AFFAIRS, CHAPTER 85A – GUAM MASTERS AWARD.

WHEREAS, the Masters Program initially came about from a 1996 CAHA grant to artist Ron Castro that documented the life traditions of many of Guam's folk and traditional practitioners. As a result, CAHA recognized the need and importance of documenting existing traditions that were an essential part of Guam's people and their way of life, that were literally passing away before us.

WHEREAS, CAHA memorialized these individuals by bestowing them the title of "Master" in the tradition they excelled in. They were memorialized through the production of "A Tribute to the Masters of CHamoru Tradition" Poster Series (56 posters) initiated in 1997; the "Path of CHamoru Traditions" which further paid tribute to these Masters with bronze lattes embedded into the sidewalks surrounding Skinner Plaza; and a coffee table book entitled "A Journey with the Masters of CHamoru Tradition produced in 2000.

WHEREAS, for many years, no other cultural practitioners were presented the title of "Master". Of the masters who were officially recognized in the initial poster series and coffee table book, less than a dozen of those "living treasures" remain with us today.

**WHEREAS**, throughout the years, Guam CAHA, other government agencies and cultural nonprofit organizations have continued to perpetuate and promote the Chamorro culture and traditions.

**WHEREAS**, in 2010, Guam CAHA's Board decided to resurrect the Masters Program. The Board realized its intrinsic value and that the transmission of these practices from generation to generation was imperative to ensure the preservation of our CHamoru traditions.

**WHEREAS**, the depository of the CHamoru heritage is in the minds of these cultural practitioners whose bodies are the vehicles in which the knowledge and skills of that tradition are manifested and performed.

WHEREAS, the intent to reinstate the Masters program was to give due recognition to those practitioners and to safeguard/support the knowledge and skill related with traditional artistry through the continued practice of the craft within the community. As a result, Public Law 30-139 was enacted in 2010 and established the Guam Masters Award. The award was created to recognize master practitioners of Guam's Traditional and Folk Arts.

WHEREAS, the award gives due recognition to these master practitioners for their artistry and craftsmanship, and their continuing efforts to preserve Guam's rich history and cultural traditions through the practice and perpetuation of their arts.

WHEREAS, the award acknowledges artists whose contributions, primarily through teaching, advocacy, organizing and preserving important repertoires, have greatly benefited their artistic tradition; and whose efforts have significantly increased opportunities for and public visibility of traditional and folk arts.

**WHEREAS**, the award guarantees the continuity of our cultural traditions, leaving the children of Guam a vested legacy.

**WHEREAS**, since the enactment of Public Law No. 30-139, CAHA has bestowed the award to eight cultural practitioners. The last award was presented in 2015.

**WHEREAS**, in 2020, the World Health Orginization declared COVID19 a pandemic, as a result, the call for nominations for the Guam Masters Award was postponed.

**WHEREAS**, in accordance with Title 5, Division 8, Chapter 85A, CAHA will open the nominations for the Guam Masters Awards to the public in April 2024.

**WHEREAS**, FURTHERMORE, moving forward CAHA will begin accepting nominations annually instead of quadreannually subject to the discretion of the Board.

NOW, THEREFORE BE IT RESOLVED, that the Board approves and reaffirms, this resolution in conformance with Title 5, Division 8, Chapter 85A:

WHEREAS, now in its 52<sup>nd</sup> year, the FestPac celebration held every four years, showcases singing, dancing, painting, weaving, carving, live demonstrations, storytelling, canoe building, and other forms of artistic traditions unique to the Pacific regions of Micronesia, Melanesia and Polynesia for two weeks. It is a time to celebrate the people of Oceania, to share history and knowledge, raise cultural awareness and create memories. FestPac celebrates the diversity of cultures and artistic expression found among Pacific Islanders, and also shows the similarities that connect us as People of the Pacific.

WHEREAS, FestPac emphasizes the importance of traditional art forms, encourages the creation of new forms of artistic expression, promotes the use of indigenous languages, raises awareness and celebrates the rich cultural heritage of Pacific Islanders.

WHEREAS, FestPac has grown from the 1st South Pacific Festival of Arts held in 1972 with 1000 participants from 20 countries to this year's 13th Festival of Pacific Arts with close to 2700 participants from 27 countries expected.

WHEREAS, Guam has participated in every FestPac since its inception in 1972. The first festival was held in Fiji and Tan Elena Benavente, Master Weaver, being Guam's only delegate.

WHEREAS, Guam served as host the 12th FestPac in 2016 during which 3500 delegates from 27 Pacific island nations came together.

WHEREAS, the next FestPac, the 13<sup>th</sup> Festival of Pacific Arts will be held from June 6 -16, 2024 in Hawaii. WHEREAS, the Guam Council on the Arts and Humanities Agency (CAHA) has coordinated Guam's participation at nearly every FestPac.

WHEREAS, the 13<sup>th</sup> FestPac Guam Committee led by Chair Monica Guzman, along with Dr. Judy Flores and Maria Barcinas [Co-Chairs, Demonstrations, Exhibitions, Special Events and Activities (D.E.S.E.A.); Dr. Michael Bevacqua (Chair, Literary Arts) and Master of CHamoru Dance, Eileen Meno

(Chair, Performing Arts) and CAHA Management and staff support will be bringing a 100-member delegation to the 13<sup>th</sup> FestPac scheduled for June 6 -16, 2024 in Hawaii.

WHEREAS, Guam's 100-member delegation to the 13<sup>th</sup> FestPac is comprised of Guam's best and finest traditional and cultural practitioners representing all genres.

WHEREAS, in accordance with Public No. 35-60, no more than Three Hundred Fifty Thousand Dollars (\$350,000) of the arts in public buildings monies may be used to pay for airfare expenses for Guam's delegates to the 13<sup>th</sup> FestPac, shipping expenses, logistical support and other related expenses, as approved by the governing board of CAHA.

**NOW, THEREFORE BE IT RESOLVED**, that the Board approves and reaffirms, the budget presented by the 13<sup>th</sup> FestPac Chair for the Official Guam Delegation to the 13<sup>th</sup> Festival of Pacific Arts 2024.
